## Rate Schedule

\*\*\*Three days attendance per week is required and will be billed regardless of attendance.\*\*\*

Infants are only enrolled on a weekly basis.

### Multiple Child Families

A 10% discount is offered to families with multiple children. It is available for children attending full time, full days, and only if tuition is paid on time. (The 10% discount is not available for infant or one year old tuition.)

**Charge for late payment of DES co-pays** \$15.00 per week

**Annual Supply, Registration & Insurance Fee** \$30

Due in September and upon enrollment

**Hourly Rate beyond Maximum Hours per Day** \$7.00 per hour

Maximum Extra Hours Charge for School Age Children on School Holidays during the school year is \$15 per day.

**Extra Hours Charges:** Regular rates include 11 hours of care. Hours of care provided in excess of these limits will be charged at the regular hourly rate. DES families authorized for half days only are entitled to a maximum of 6 hours per day. Families paying the weekly, part day rate are entitled to 4 total hours of care per day.

## **Policies & Procedures**

Payment is due by the Wednesday of the week of service. *To receive the early bird discount payment must be made by Wednesday of the week of service.* Daily customers will pay an estimate of expected charges on the first day service is provided for the week.

Tuition is not refundable. Families must provide two weeks' notice prior to disenrollment. Families that do not give notice will be charged for two weeks of care.

Weekly rates are substantially discounted and are charged whether the child is here or not. Weekly rates are based on the yearly cost of care spread out over 52 weeks. As such, there is no discount for weeks that include a holiday. Two weeks of vacation credit is allowed per year and only if taken. Vacation weeks are Monday through Friday. Families may not rotate back and forth from weekly to daily rates.

**Collections:** In the event action is brought hereof, the prevailing party shall be entitled to recover from the other party the court costs and attorney fees as determined by the court. If this account is referred to collection, the other party will pay for all collections up to 50% of the balance owed.

**Interest:** Delinquent accounts will be charged 1.5% interest per month.

**Insufficient Funds:** In the event that a check you write is returned for insufficient funds, or any other reason, you will be charged \$25.

**DES Families:** Co-payments are charged on a full day, weekly basis whether or not your child attends. This may be considered as additional charges depending on client attendance. Attendance of three days per week is required. Families will be charged the appropriate daily rate if children do not attend a minimum of three days per week. Families of infants and one year olds should review the separate infant and one year pricing policies.

**Absence Policy:** Families are requested to provide a one-day notice of upcoming absences. Parents may be charged the full daily rate if notice is not provided.

**Late Rate:** Children not picked up by 6:30 PM will be charged a minimum of \$10 and an additional \$5.00 for every 5 minutes late.
